Re: 2010 Annual Reports By Pacific Gas and Electric Company

Dear Mr. Clanon:

The purpose of this letter is to request extensions for Pacific Gas and Electric Company (PG&E) of the due dates of certain annual reports for the year 2010. Specifically, PG&E respectfully requests extensions from March 31, 2011 to May 31, 2011, for certain of the General Order (G.O.) 77-M report items for 2010. PG&E also respectfully requests extensions of the due dates for the G.O. 104-A, and Gas Pipeline Replacement Program (GPRP) annual reports from March 31, 2011 to May 2, 2011.

PG&E is required to file the following annual reports for the previous calendar year by March 31 annually:

- Per G.O. 77-M, Annual Report of Data on Dues, Donations, Subscriptions, Contributions and Legal Fees;
- 2. Per G.O. 104-A, PG&E Annual Report;
- 3. Per G.O. 104-A, Standard Pacific Gas Line, Inc. Annual Report; and
- 4. Per Decision 86-12-095, GPRP Annual Progress Report.

For the G.O. 77-M report, per Decision 06-12-029, compensation items are due to be filed on or before May 31 of each year. However, G.O. 77-M still requires items relating to dues, donations, subscriptions, contributions and payments to attorneys be filed by March 31 each year. In order to allow sufficient time to organize the recorded information from the prior calendar year, and to enable PG&E to file a single rather than bifurcated G.O. 77-M report, PG&E requests an extension of the due date for these items to May 31, consistent with the due

date for compensation data. This request is also consistent with extensions that the Executive Director has granted in prior years.

For the G.O. 104-A reports, part of the financial information required in these reports is, with minor exceptions, duplicative of the information required in annual reports submitted to the Federal Energy Regulatory Commission (FERC) that are due on or before April 18 each year. In past years, PG&E requested extensions until April 30 of the CPUC annual report due dates to ensure consistency with the annual reports to the FERC, and the Executive Director granted these requests. PG&E is this year requesting an extension from March 31 to May 2, 2011 (April 30 falling on a weekend), in the due dates for the G.O. 104-A reports for 2010.

For the GPRP, in past years, PG&E has requested and been granted 30-day extensions to process and analyze the data supporting the report. PG&E is this year again requesting an extension from March 31 to May 2, 2011 for this report.
