This letter documents an agreement between Energy Division and the IOUs regarding the utility tracking data that is due on March 1, 2011. PGE, SCE, SDGE, and SCG will submit utility tracking data that represents utility reported accomplishments in 2010, in the format agreed upon with Energy Division, by March 1, 2011, pursuant to \_\_\_\_\_.

Per \_\_\_\_\_, the utilities are also allowed to claim energy savings for CFLs that were purchased in the 2006-2008 time frame, but were not installed until subsequent years. This estimate for CFLs purchased in 2006-2008 but installed and generating savings in 2010 is not yet available. As a result, the utilities should be able to update their March 1, 2011 tracking data, for the sole purpose of adding these additional CFL savings, once they become available. No other updates can be made unless further authorized by the Commission.
