Hi Jeorge,

Thank you for putting this letter together. We are required to submit an Annual Report on May 1, which as a requirement resubmits, as attachments, the final monthly and quarterly reports for 2010. In the event that a financial transaction changes, or a workpaper is approved or modified, could you structure the letter in a way that allows for the Annual Report to constitute the final claim.

An example may also include Codes & Standards. We are allowed net benefit credit for post-2005 Codes & Standards as they impact 2010, but that analysis wont be complete by March 1. In general, we typically do not have any substantive changes, but allowing for it up front in the event they may occur will eliminate the possibility of two differing data sets for the same time period.

This letter documents an agreement between Energy Division and the IOUs regarding the utility tracking data that is due on March 1, 2011. Pursuant to Decision 07-09-043 Attachment 6, PGE, SCE, SDGE, and SCG will submit utility tracking data that represents utility reported accomplishments in 2010, in the format agreed upon with Energy Division, by March 1, 2011.

Per Decision 10-12-049 p.60, the utilities are allowed to claim energy savings for CFLs that were procured and rebated in the 2006-2008 time frame, but were not installed until subsequent years. The estimate for CFLs procured and rebated in 2006-2008 but installed and generating savings in 2010 is not yet available, but will be available soon. As a result, the utilities are permitted to update their March 1, 2011 tracking data, for the sole purpose of adding these additional CFL savings, once they become available. The IOUs will submit their updated tracking data within 30 days after the updated CFL information becomes available. This updated submission will be considered part of the March 1, 2011 submittal and will serve as the basis for 2010 program year savings and associated incentive claim. No other updates can be made unless further authorized by the Commission, Energy Division, or Assigned ALJ, as appropriate.
