Hi Amy,

The 2008 WREGIS Certificates were retired in January 2011, prior to the CEC's February 1, 2011 deadline for the 2008 compliance year. PG&E began retiring its 2008 WREGIS certificates following the January 5, 2011 publication of the CEC's Fourth Edition of the RPS Eligibility Guidebook. In the fourth edition of the RPS guidebook, the CEC provided guidance on the procedure for retiring WREGIS Certificates, including such details as timing of the retirements, the naming convention for the WREGIS retirement subaccounts, the process for reporting the retirement information to the CEC, and the procedure for supplementing WREGIS Certificate reporting using the CEC's interim tracking system (i.e. the RPS Track Forms).

Is there a reason that the 2010 date is important?

Hi Amy,

For compliance year 2008, PG&E retired 6,602,924 MWh of 2008 WREGIS certificates in accordance with procedures in the Fourth Edition of the CEC's RPS Eligibility Guidebook. The CEC guidelines required that the 2008 WREGIS Certificates be retired by February 1, 2011. Since WREGIS was not used for all of 2008, PG&E reported the balance of its 2008 RPS procurement (3,209,439 MWh) using the CEC's 2008 RPS Form. PG&E's total reported RPS procurement for 2008 was 9,812,363 MWh.
