On the "exemption" point you make, maybe you've seen SoCalGas and SDG&E's advice letters asking to develop biogas purifying technologies under our Non-tariffed Products and Services program (Rule VII). In it, they repeat the part of the rule that specifies they have to, among other things, use a portion of the utility's excess capacity to provide the NTP&S. Exploiting whatever scale economies that are available in these assets is the purpose of this program. However, no excess capacity is identified in their proposal, and they apparently anticipate this problem because they ask that that requirement be waived for this project! Almost fell out of my chair. Chitzpah doesn't even begin to cover it.
