2011 GRC – Phase II Settlement Parties

This afternoon Gail Slocum of PG&E called ALJ Pulsifer to follow up on the Settling Parties' request for a proposed revision in the procedural schedule for the filing of the rebuttal and surrebuttal testimonies. The request was made in the Settling Parties' Status Report update to the ALJ which was filed on February 18, 2011.

ALJ Pulsifer stated that he is finalizing an ALJ Ruling, expected to be issued by tomorrow, granting the Settling Parties' requested due date changes. The ALJ asked PG&E to pass along the bottom line news to the Settling Parties today, and we are glad to do so.

The proposed revisions to the procedural schedule were:

- Extend rebuttal testimony filing date from March 4, 2011 to April 29, 2011
- Extend surrebuttal testimony filing date from March 25, 2011 to May 20, 2011
- Establish a date of April 8, 2011 for the next status report update to the ALJ.
