

SDG&E's Cost Allocation Mechanism ("CAM") Group Nominations

BACKGROUND, ROLE AND RESPONSIBILITIES

San Diego Gas and Electric Company (SDG&E) is actively seeking at least two nominees to join SDG&E's Cost Allocation Mechanism ("CAM") Group. Pursuant to California Public Utilities Commission ("CPUC") Decision ("D.") 07-12-052, the CAM Group will act in an advisory capacity when SDG&E seeks to procure new generation resources and recover the costs associated with energy and capacity from "all benefiting customers" in accordance with the CAM established in D.06-07-029, *et seq.*

QUALIFICATIONS AND SELECTION PROCESS

A detailed description of the qualifications required for CAM Group participation, is set forth in Appendix D of D.07-12-052 (attached). **SDG&E is seeking nominations for Direct Access ("DA") representatives.**

To be eligible to participate in SDG&E's CAM Group, nominees must be an end-use customer of SDG&E or an individual hired to represent end-use customers' interests. Wholesale market participants and representatives of wholesale market participants are not eligible to participate. Nominees must supply a current curriculum vitae and demonstrate their eligibility to participate in the CAM Group by providing a client list or other documentation certifying they do not represent market participants. **Responses must be provided in electronic form to the SDG&E contact listed below on or before February 18, 2011.**

All Respondents will be pre-screened to assess the potential for a conflict of interest.

NOTIFICATION AND FUTURE PARTICIPATION

Nominees selected to participate in the CAM Group will be notified via e-mail or telephone by February 28, 2011.

CAM Group members will be required to execute and comply with the attached Non-Disclosure Agreement. Failure to execute this agreement (which cannot be modified) will result in disqualification from the CAM Group.

To the extent possible, CAM Group members must participate in all CAM Group meetings. SDG&E expects to convene its first CAM Group meeting in the February-March 2011 timeframe. CAM Group meetings will be held in SDG&E's San Francisco office, a call in number will be provided to enable remote participation.
