I have been working with Jennifer Kalafut to arrange a follow-up meeting on Qualifying Facility interconnections for next Monday April 4, 2011. At this meeting we will further discuss the QF interconnection process. PG&E plans to give a presentation on its FERC/CAISO process proposal as compared with the current Rule 21 interconnection process, answer any questions the CPUC may have, and discuss possible alternatives. Also, if available, PG&E will offer a preliminary summary of any feedback it received from stakeholders since its March 15, 2011, stakeholder workshop in San Ramon.
