George:

On issue #2 regarding the Risk Reward Spreadsheet template, based on our conference call with the other IOUs on February 9th, here are the issues that were discussed or agreed upon.

1. It was agreed that the cumulative savings for 2006 - 2008 should be based on the final true-up claim decision, net ex-ante savings with EDIRate, and not the cumulative savings shown on the draft spreadsheet which was based on net ex-post savings.
2. The energy savings based on the 50% decay was discussed. The IOUs stated that the 50% decay should last for the entire forecast period since the decision for the 50% decay was based on 50% of the market being transformed as the result of the programs. The current cumulative analysis only provided 50% decay for one year after the EUL drop off. You were going to confirm the decision for the 50% decay and modify the cumulative analysis to reflect the decision.
3. SCE recommended that the 04 - 05 EE section be deleted instead of just struck out as shown in the draft.
4. We recommended that the Earnings cap section be deleted or updated since the cap applies to 2006 - 2008, not 2006 - 2009.

These are the issues and agreements I remember from the February 9th conference call regarding the Risk Reward Spreadsheet template.
