**NOTICE OF *EX PARTE* COMMUNICATIONS
OF PACIFIC GAS AND ELECTRIC COMPANY**

Pursuant to Rule 8.3(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following ex parte communications. The communications occurred on Wednesday, March 2, 2011 at approximately 1:30 p.m., and Thursday, March 3, 2011 at approximately 1:30 p.m. (respectively), by telephone to the offices of the California Public Utilities Commission. The communications were oral. [(Rule 8.3(a)]

John Hughes, Director-Regulatory Relations, PG&E, initiated the communications with Scott Murtishaw, Advisor to Commission President Michael Peevey. [Rule 8.3(b)]

Mr. Hughes called and spoke with Mr. Murtishaw on Wednesday, March 2. Mr. Hughes said that Ordering Paragraph (OP) 42 in both the Proposed Decision (PD) and the Alternate Proposed Decision (APD) referred to a March 1, 2011 compliance date for reporting certain information on expense and capital expenditure information. He stated that since a final decision

will not be issued before March 24, 2011 at the earliest, it would not be possible to comply with the March 1 date. Mr. Hughes asked that PG&E be permitted to file the first of these compliance reports 90-days after the final decision is approved by the Commission. He further stated that PG&E can comply with the March 1, 2012 and 2013 dates addressed in the same OP 42.

Mr. Hughes called back on Thursday, March 3, and left a voice mail message for Mr. Murtishaw. He stated that in the comments on the PD and APD that PG&E will be filing on March 14, 2011, it will address some income tax effects associated with the accelerated amortization of the electromechanical meters. He stated that it will result in a slight increase in the revenue requirement. He also stated that the company is still quantifying the effect but expects it to be around \$2 million to \$5 million.
