## NOTICE OF SUBSTITUTION OF PARTY

On October 14, 2010, the CPUC issued Decision (D.) 10-10-017 (Decision) in the consolidated matters, A.09-10-028 and A.10-04-032.<sup>1</sup> The Decision approved the Sierra Pacific Power Company's (Sierra) (U903E) transfer to California Pacific Electric Company, LLC (CalPeco) (U933E)<sup>2</sup> of the California electric distribution facilities and the Kings Beach Generating Station that Sierra had owned and been operating. The net effect of the transfer upon closing was that the responsibilities of Sierra as a Public Utility in California terminated (OP 7) and CalPeco assumed them instead. As such, CalPeco stepped into the "shoes" of Sierra in all pending matters before the CPUC (list appended).

The CPUC has permitted CalPeco to replace Sierra in all pending proceedings without the necessity of filing a Motion for Party Status pursuant to Rule 1.4, and this authority extends to the replacement of Sierra on all applicable Service Lists as well. However, Sierra has the right to remain on all Service Lists in the same capacity it had immediately before the rendering of the Decision, and Sierra has expressed a desire, in some instances, to remain a "Party," and in others, to be removed altogether, and still in others, to be placed on the "Information Only" portion. In any event, CalPeco will be an "active" party in all of the proceedings listed on the attached list. This notice is to inform you of (1) the substitution of CalPeco for Sierra or (2) the addition of CalPeco to those proceedings and the concomitant revisions to the Service List.
