Panama, Jeanne, Simon, et al,

My EUC folks forwarded the message below requesting a statement from the CPUC and the IOUs regarding the gas sweep at Friday's meeting. We, just as you, are deeply concerned about this sweep and continue to oppose the use of energy efficiency funds to fill the budget gap.

As you know, given all the uncertainty with the gas sweep (whether the Governor will sign the bill into law, how and which programs it will impact, the mechanics of the transfer and timeframe, if the transfer will continue through 2012, etc), PG&E is unable to assess the impact of the gas sweep on any of its programs at this time. In the event that the sweep is signed into law, we'll need to work with the CPUC regarding the availability of funding and changes in program design/funding, etc. I expect that there will be opportunities for public and stakeholder comment on proposed decisions and options. Ultimately, the CPUC will need to issue a final decision on how we proceed.

Given the uncertainty and the many potential complicating factors of the sweep, I encourage the EUC team to remain focused on what we can control for the time being -- making EUC succeed.

I hope this write-up can serve as PG&E's statement on the matter so that Friday's meeting can be solely focused on moving EUC and energy efficiency forward.
