**Re: SDG&E's 2012-2014 Demand Response Application No. A.11-03-002**

On March 1, 2011, SDG&E submitted its Application and testimony in support of its Demand Response Programs for 2012-2014. SDG&E has identified some corrections to its March 1, 2011 testimony which are identified in the Amendment Log attached as Attachment A.
