Pursuant to the supplemental Advice Letter (SCE AL 2445-EA, et. al) jointly filed by Pacific Gas & Electric Company, Southern California Edison Company, Southern California Gas Company, and San Diego Gas & Electric on April 27, 2010, the Joint IOUs hereby respond to the following requirement related to the local government strategic plan menu:

"IOU contract managers will update the spreadsheet on a schedule of once every six months beginning September 2010 to reflect progress on the goals and milestones. The IOUs will add a column to the spreadsheet to track and record this progress for each partner. The header of the column will reflect the date of the latest semi-annual update." (p.3)

The IOUs submitted the first report in September 2010, the attached represents the second report of the program cycle through March 2011. Per your request, we will also upload these reports to EEGA.
