As I indicated in my voice mail to you, TURN hereby requests a two-day extension of the April 11 deadline for opening comments in this Rulemaking (pursuant to OP 6 of the OIR). On March 30, Commissioner Florio issued a Ruling scheduling oral argument on April 11 concerning the Stipulation on the Order to Show Cause, and memorializing the briefing scheduling on the Stipulation. Due to these new deadlines, as well as other matters, TURN requests the two-day extension. We do not believe that such an extension will impair or delay resolution of any matters in this proceeding.
