Thanks Bill. Just fyi, we will be getting an official notification to PG&E from CPSD Deputy Director Julie Halligan. There will be some additional information that we want to get going forward, for example, related to copies of the finalized protocols and plans referenced in the letter, testing protocols for the cans removed to perform the hydrotesting, more detailed information on the test segments, and the like, but we anticipate giving the go ahead. Our staff is satisfied that we can work these things out as it goes along. We have also consulted with the expert from the Independent Review Panel (Mr. Nickell) to better understand the concerns about hydrotesting he had conveyed to Paul Clanon and he is comfortable that the 1.5 MAOP test pressure level, in combination with testing of the removed pipe, results in only a very slight risk and he encouraged the testing move forward ASAP. He will give us some additional feedback tomorrow but said that based on our description of the plan, no need to hold up beginning the notification process, so, this is not the official go ahead but expect it before 5:00.

I am now moving to the customer notification and hope to get that back to you soon.
