Subject: R.07-05-025 DA OIR - ALJ Pulsifer allows FEA to reply to responses to its petition for modification

In the event parties file responses to FEA's March 10, 2011 Petition for Modification of Decision 10-03-022, ALJ Pulsifer has granted FEA's request to file a reply to responses pursuant to Rule 16.4(g). In a telephone conversation and subsequent e-mail correspondence with FEA counsel yesterday, the ALJ exercised his discretion under Rule 16.4(g) to set the date for FEA's reply, addressing two of my concerns: 1) the possibility of a furlough of Federal employees on or about April 9, 2011 as a result of the current Federal budget impasse and 2) a previously scheduled trip taking me out of the country April 23-30. In the event of a furlough, ALJ Pulsifer will allow the filing of FEA's reply ten days after the end of the furlough or May 3, 2011, whichever date is later. If no furlough occurs, the reply will be due within ten days after the last day for filing responses.
