Communication was oral and written; the twelve written documents provided

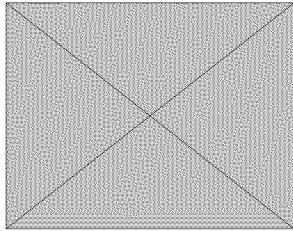
