The following were next steps from my notes following our meeting today. Please add/revise if I missed something:

1. PG&E to provide info on what parties protested prior advice letter requests for use of prior period unspent funds:

- PG&E AL 2938-G/3298-E (augmenting 2006-2008 EE program cycle funds approved by Resolution G-3421) was protested by DRA.
- PG&E AL 3030-G/3487-E (augmenting 2009 EE program cycle funds approved by Resolution G-3439) was protested by DRA and Local Government Sustainable Energy Coalition.

2. IOUs to update draft Memo Step 3 table on page 5 for SDG&E values; move line 5 below line 14 and adjust for commitments; add note defining commitments.

3. IOUs to finalize revised data request response - update Q.5 for PG&E's receipt of 4th quarter 2010 remittance; IOUs break out Q10 detailing incentives, contracts and IOU labor and create aggregate response if IOU details are available and comparable.

4. We should all consider procedural options including short term fix (e.g. implement Steps 1, 2 and 3 for at least use of unspent gas funds) as the funds could be swept as early as July 2011 if SB 69 is signed into law.

5. ED staff/CPUC legal and ALJ Farrar to discuss procedural options and get back to PG&E and Sempra.

6. Schedule further discussion.

7. IOUs continue to pursue with ED staff steps 1-3 on p. 6 of the memo (outstanding interest, finance dept forecast admin cost in rates, interstate pipeline customer payments) and contact Simon if we need further support.
