Hello friends and fellow Aspen Accorders,

It was great to see most of you at last week's meeting.

I want to take a moment to thank each of you for considering my candidacy for the California State Assembly in 2012. We share policy goals on the issue of energy efficiency and alternatives. But, we are also friends. I am grateful for that and for any help you can provide for my campaign.
