Hi Simon-

Following up on your request for an updated contact list, we wanted to let you know of a few changes the utilities recently made to the Statewide Program IOU Lead assignments. In particular, we have new IOU leads for Commercial, Agricultural, New Construction, and Lighting Market Transformation. We have also assigned co-leads for the Residential program, due to the large number of subprograms under Residential.

These changes were implemented to accommodate the bandwidth of each of the utilities, and to ensure the IOUs continue to be as responsive to Energy Division as possible.

While the change in SW leads shifts some of the administrative responsibilities among the utilities, the IOUs' commitment to joint collaboration and coordination remains an equal priority for all the utilities.
