

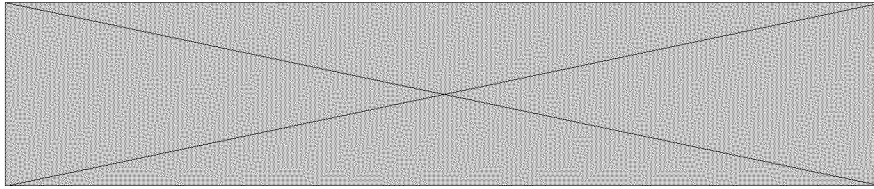

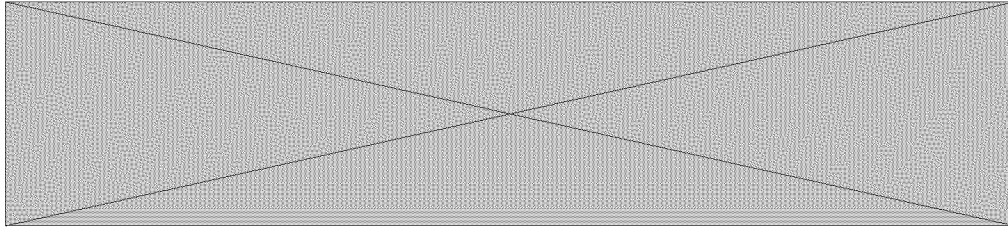
### **CPUC Launches Lighting Action Plan**

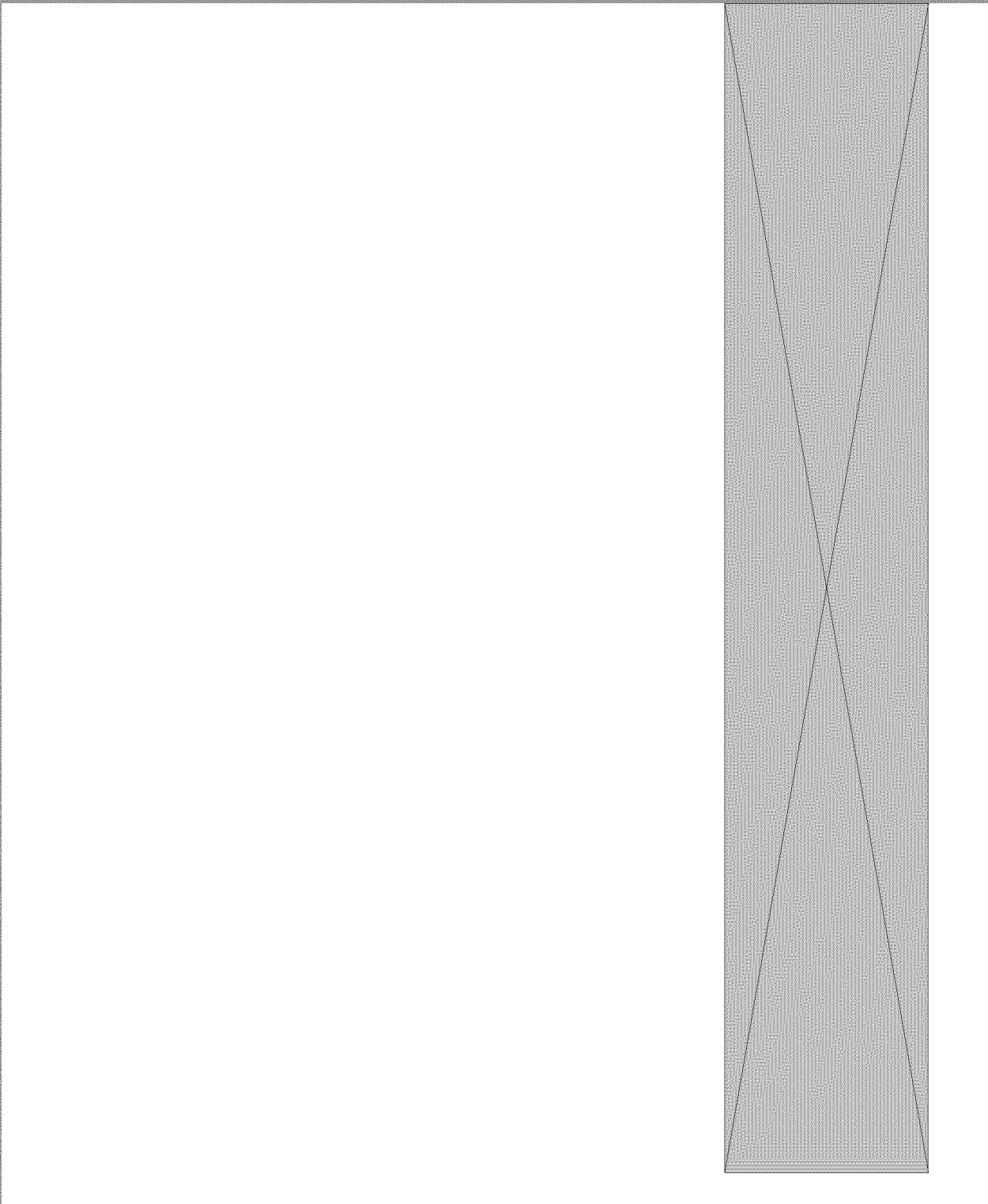


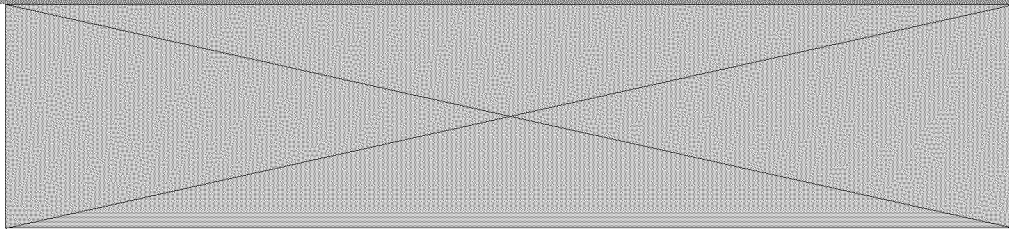
