PPM Table Compliance Issues

PPM General

- ED would like to request that the IOUs collaborate to submit a single table with PPM reporting aligned across all the IOUs (i.e., same rows) with as few references as possible to separate tables.
- PPMs should be provided by SW program in one tab, with a column for each IOU for 2010.
- Each PPM should be provided in full in the single tab. That is, if a PPM needs many rows to be reported, all those rows should be in the single W tab with clear numbering (i.e. PPM 16.1, 16.2, etc). Assumptions informing calculations should be shown on a separate tab.
- IOUs should ensure that numbering for each PPM lines up exactly, so that comparisons can be made across IOUs apples to apples.
- PPM HVAC-1 IOUs report in different units (e.g., kWh/ton, kw/ton, units, tons) Needs to be standardized or reported in several units.
