Hello,

I hope you're all well. It has been brought to my attention that the IOUs are not providing our

contractors with billing data in order to conduct the EE evaluation. I believe the reason cited is SB1476 which enacted PU Code Section 8380 and specifically subsection (e)(2) which you believe requires the CPUC's contractors to sign an NDA with the IOUs.

We do not allow our contractors to sign an NDA when they are acting within the scope of work being done under the CPUC's contracts. Our contractors are an extension of the CPUC and have signed on to an NDA provision as part of the the T&Cs of the contract. PU Code Section 8380(e)(2) does NOT apply to CPUC contractors but applies to third parties who have a contract or will enter into a contract with the IOUs for the specific programs enumerated in statute.

I'd be more than happy to discuss this with you further. However, our consultants need the data ASAP. If you will not give them the data, please treat this as an official data request - see details below.

We need to address this issue soon so let me know if you need further discussion on this matter.

1. Monthly Billing Data. For all non-residential customer accounts, please include all monthly kWh, monthly maximum kW, and/or therm reads for all time-of-use (TOU) periods. Please include billing histories spanning October 1, 2008 through the most current billing cycle. In addition to these monthly consumption data, please include account numbers, meter numbers, meter read dates, the number of days in each billing period, the associated account numbers, any codes to indicate the type of meter reads that occurred, rate code and any other information that would be deemed pertinent to these evaluations.

2. Customer Information System Data. For all non-residential customer accounts, please provide all customer information. Please include customer identification number, premise/site identification number, customer name, full customer address including city, state, and zip code, full service address including city, state, and zip code, customer phone numbers, customer business name, NAICS and SIC codes for the facility, customer's associated weather station and climate zone, any flags or identifiers used for AB1103 Benchmarking, and any other information that would be deemed pertinent to this evaluation. Any additional fields that can be used to aggregate accounts to a site are also requested. Please be sure that account numbers are in the same format in each dataset (i.e. preceding zeros or dashes appear in the same format). Please provide a data dictionary with explanations for each field.

3. Interval Meter Data. For a selected zip-9 code, please also provide all interval meter data. Please choose a zip-9 code which was among the earliest to have smart meters installed. This should include an account number or other identifier to associate the interval data with the

billing data and CIS data. This will serve as an example to be reviewed for content. Please be prepared to provide interval data for a list of requested participants at a later date.

Since these files will be large and voluminous, we recommend each utility uses the CPUC's Secure File Transfer system. PGE and Sempra have used this system before and are familiar with it. Utility staff should coordinate with Jeorge Tagnipes of the Energy Division to ensure proper delivery using the CPUC's Secure File Transfer system.
