Subject: Rulemaking 11-03-006 - Ruling On CDWR June 16, 2011 memorandum

Good morning. On June 16, 2011, the California Department of Water Resources (CDWR) submitted a memorandum to Paul Clanon, Executive Director of the California Public Utilities Commission (Commission), in which CDWR requested that the Commission make modifications to the Operating Order that is applicable to San Diego Gas & Electric Company and which was approved in Decision 11-03-004 (Attachment 6 to that decision).

Today's e-mail ruling notices all parties to Rulemaking 11-03-006 (the successor docket to Rulemaking 09-06-018) of the CDWR's June 16, 2011 memorandum, which shall be treated as a petition for modification. Pursuant to Rule 16.4(f) of the Commission's Rules of Practice and Procedure, parties may file and serve responses to this petition by July 18, 2011.

A copy of CDWR's June 16, 2011 memorandum is attached to this email ruling.
