**SUBJECT: SUPPLEMENT TO ADVICE LETTER REQUESTING APPROVAL OF POWER  
PURCHASE AGREEMENT WITH NRG SOLAR BORREGO I, LLC**

### **I. PURPOSE**

San Diego Gas & Electric Company ("SDG&E") hereby submits to the California Public Utilities Commission (the "Commission" or the "CPUC") this supplemental filing to Advice Letter 2236-E, which requested approval of a 25 year Power Purchase Agreement ("PPA") between SDG&E and NRG Solar Borrego I, LLC ("NRG Solar") for the purchase of renewable power from a newly constructed solar facility located in Borrego Springs, California (the "Proposed Project"). Since that Advice Letter was filed on March 14, 2011, SDG&E and NRG Solar have agreed to amend the PPA ("First Amendment"). This supplemental filing describes the First Amendment and requests that the Commission approve the PPA, as amended by the First Amendment.

### **II. BACKGROUND**

The Proposed Project began as a bid from the 2009 RFO and evolved into bilateral discussions between SDG&E and NRG Solar that commenced with the unsolicited submission of an offer for the Proposed Project in August of 2010. The PPA will provide approximately 60 GWh/year from a 26 MW solar photovoltaic project located in Borrego Springs, California. This new resource also has the potential to bolster grid reliability for the Borrego Springs area.

The parties executed the First Amendment on June 27, 2011. The amendment will adjust the contract price and delay certain deadlines in the contract, including, Guaranteed Commercial Operation Date ("GCOD"). The original GCOD of July 31, 2012 will be changed to October 1, 2012.

### **III. EFFECTIVE DATE**

SDG&E respectfully requests that this supplemental filing becomes effective concurrent with Advice Letter 2236-E, as amended by July 28, 2011, but in no event later than August 18, 2011.
