Thanks David (and Jaclyn!). Sorry for the delay, I was out of town last week.

Following up- my focus is on the current permitting process at the local level for ground based non-thermal production of less than 50 MW-- the kinds of projects that don't come through the PUC or CEC. Questions include: Anecdotally or more generally, how long does the permitting process take? What differences have emerged between counties? What similarities exist?

Does this help? The basic issue is that there are 58 counties in CA with potentially 58 different processes-- but there are movements to coordinate this process, and so I'm working on figuring out where we stand and where we might be/should be headed.
