The goal of this symposium is to provide a practical understanding of in-line inspection technology (also known as smart pigs), how they work, the science behind in-line inspection tools, what information in-line inspections can provide, how the information derived from in-line inspection compares to information derived from hydrostatic testing, and to learn about the

implementation challenges to make a gas pipeline system “piggable”. Commissioners from the California Public Utilities Commission may attend and participate in the symposium.
