Subject: REMINDER: RPS Compliance Reports due August 1, 2011

Parties to proceeding R.11-05-005:

As a courtesy, staff is sending out a reminder to obligated load serving entities (LSEs) that the August Renewables Portfolio Standard (RPS) Compliance filing is due August 1, 2011. For the purpose of the August 2011 compliance report, RPS-obligated LSEs includes all Investor-Owned Utilities, Energy Service Providers and Community Choice Aggregators.

RPS-obligated LSEs should take note of the following important items:

- On June 15, 2011, the California Energy Commission (CEC) adopted its

2007 RPS Verification report. RPS-obligated reporting LSEs are required to file "Verified" compliance reports within 30 days after the CEC issues its Notice of Availability of an RPS Verification Report. (See November 20, 2008, Ruling (R.08-08-009)) Provided that the CEC issues its Notice of Availability on or after June 30, 2011, RPS-obligated LSEs may file a single compliance report on August 1, 2011, that meets both the Verified and August reporting requirement.

- The compliance reports shall be served to the service list for R.11-05-005 and filed with the Energy Division on August 1, 2011. (Refer to the reporting spreadsheet for specific instructions)
- The compliance reporting spreadsheets are available on the California Public Utilities Commission's website:

- RPS-obligated LSEs are encouraged to read the RPS compliance reporting spreadsheet's Instructions tab carefully.
- Unlocked versions of the spreadsheets are available upon request.
- Late or incomplete RPS compliance reports are subject to the citation schedule in Resolution E-4257. Filings must contain all sections of the staff provided reporting template to be considered on time.
