In response to this data request, PG&E has provided the complete Gas Report Operations exhibits from the 1987, 1993 and 1996 GRCs. The exhibits include testimony supporting both the gas transmission and distribution pipeline expense and capital projects forecast in these rate cases. PG&E has provided the complete exhibit because the capital additions chapters in the exhibits generally include only a description of the forecast methodology used to calculate capital additions, whereas the distribution and transmission project descriptions are included with the chapters related to the expense forecasts.

PG&E is unable to locate the testimony for gas transmission and distribution pipeline projects for the 1990 Test Year GRC (A.88-12-005). PG&E will continue to search for this information and, if it is located, will forward a copy to you.
