#### EXHIBIT A

#### COMMENTS

Southern California Gas Company (SoCalGas) and San Diego Gas & Electric (SDG&E) recommend in section III of their opening comments, that the Commission consider alternatives to pressure testing or replacement in evaluating proposed implementation plans. In particular, the alternatives SoCalGas and SDG&E recommend are in-line inspection, direct examination, pressure reductions, and the recognition of pressure tests conducted prior to current regulations. Southwest Gas supports this recommendation and agrees that a range of appropriate options should be considered in order to achieve the required safety benefits. Through such consideration, costs can be carefully weighed by the Commission, as these costs will be significant to California's natural gas customers.
