On July 1, 2011, PG&E, SDG&E, SoCalGas jointly filed a Motion in A.08-07-021 et al seeking permission to shift unspent, uncommitted energy efficiency funds so as to ensure adequate funding for the 2020-2012 energy efficiency portfolio in the wake of the recently-pased SB 87.

On July 7, 2011, Commissioner Ferron issued an Assigned Commissioner Ruling and Scoping Memo in R.09-11-014 (the Rulemaking examining post-2008 energy efficiency issues) directing parties to that proceeding to comment on the requests set forth in the July 1, 2011 Motion, referenced above, and to comment on other questions raised in the Ruling. The Ruling was served on the service list in A.08-07-021 et al as well.

This note serves to confirm that comments on the July 1, Motion shall be filed in R.09-11-014 instead of in A.08-07-021 et al.
