The East Hills Mall dodged a major inconvenience on this day July 14th. Mounting power and electricity bills put the mall in jeopardy of operating in the dark. Mall owner Nick Danesh says he paid \$10,000, Wednesday and will pay \$10 thousand more Thursday. It's part of payment agreement with Pacific Gas and Electric. "We understand these difficult economic times and

with PG and E. We're very sensitive to the needs of our customers and we will always work with them, when they have a difficult time with paying their bill at any time. And this is another example of doing that," says PG&E spokesperson Redacted

Ken Mattlin of KMA Sunglasses and more says it was good day at work. "We're satisfied with the cooperation with the other tenants and with PG&E themselves with trying to work with management. And management has tried very hard."

The mall owner will start charging merchants a common area maintenance fee, in addition to their regular rent to help during these tough economic times. The Organista family came out for ice cream to support business. "Half the businesses here are running on half power, half the lights are off, we are coming here to show our support and hopefully keep hope alive."

The mall now has a nearly \$100-thousand balance with PG&E. Merchants are trying to stay positive. "I guess the wording is it is what it is we try to do the best we can and we hope we are on the winning side."

PG&E is planning an audit. The goal is see how this mall is consuming energy. PG&E will show the owner energy efficient ways to keep the bills down.
