Subject: A.11-06-006 -- Request for extension of due date

ALJ Sullivan -- The present due date for protests to the SDG&E Smart Grid Deployment Plan application is tomorrow, by my calculation. I've heard from DRA that the staff intended to propose a postponement of that due date until the due date for the PG&E and SCE applications, which were later filed. However, I've not yet seen the DRA motion or request to that effect (perhaps because we're so early in the process that the service list is very limited). I've also seen a motion from a group named Southern Californians for Wired Solutions to Smart Meters asking for a delay in the protest date.

TURN very much supports the proposed delay in the SDG&E protest date in order to have a single protest for all three applications that the Commission had indicated it intends to consolidate (D.10-06-047, p. 89).

Given that the due date is tomorrow, we also very much support you quickly indicating whether or not such a delay will be granted, to either let us know that the due date of tomorrow will remain in place, or to indicate to all parties that the extension will be granted. I know I've seen e-mails from ALJs previewing a more formal ruling that will follow. If you could issue such an e-mail here (to the service list for R.08-12-009 as well as the application itself), it might save a number of parties from scrambling around to get a protest done in the next day if it turns out the protest date is changed to be several weeks later.
