PG&E values the opportunity to comment on the Independent Review Panel Report. As indicated by opening comments filed July 15, 2011, this continued stakeholder engagement furthers our collective goal of improving gas system safety. PG&E has been carefully reviewing the recommendations made in the Panel's report, as well as proposals presented in comments on the Panel's report, as we make changes to our gas operations.

A majority of the comments submitted by the parties (including PG&E) on the Panel's Report are largely aligned with the scope and schedule for the utilities' Implementation Plans, due August 26, 2011, and do not appear to warrant a procedural or substantive change to the directives already provided by the Commission. We are diligently evaluating the specific proposals in the report and comments that are designed to improve public safety by addressing culture and processes. In addition, we are incorporating into the Implementation Plans comments received as a result of technical workshops held in June. PG&E looks forward to working with the Commission in this proceeding to adopt an Implementation Plan that thoughtfully considers the valuable feedback of stakeholders to strengthen gas system safety.
