All,

A Ruling was issued this afternoon in the RA OII (thanks [Redact]). A prehearing conference is scheduled on Aug 2, at 10 a.m. at the CPUC. The PHC is intended to focus on the following topics:

1. The scope of the proceeding and whether the preliminary determination of the scope set forth in OII 11-06-011 is adequate;
2. Whether an evidentiary hearing is necessary or whether the case can be decided on written briefs alone;
3. Use of settlement techniques or other alternatives to litigation;

4. The schedule for moving forward; and
5. Any other procedural issues necessary for prompt resolution of the proceeding.

In addition, PHC Statements are due July 26 which should address the following:

- * any proposed modifications to the scope of this proceeding as preliminarily set forth in OII 11-06-011;
- * the need for hearing (i.e., state whether hearings are necessary and if so, list the material issues of disputed fact which require an evidentiary hearing);
- * a proposed schedule for the proceeding; and
- * any other comments on items 1-5 above.

The core Team will get together to discuss next steps.
