I am very pleased to announce that Richard Clark, who has served for 11 years as Director of the Consumer Protection and Safety Division, will join the Division as an administrative law judge on August 1, 2011.

Before joining the Commission in 2000, Rich worked in labor law enforcement for over 20 years, serving as a Deputy Labor Commissioner, as the Chief Deputy Labor Commissioner of the State of California, and in operating his own private investigations agency. Rich holds a bachelors degree in history, political science and sociology from San Diego State University, and he graduated with honors from the University of San Diego's graduate level lawyers assistant program, specializing in litigation.

During his tenure as Director of CPSD, Rich was tasked with influencing and implementing, and heading the enforcement of, the Commission's consumer protection and safety policies relative to electricity, natural gas, communications, household goods carriers and passenger carriers, and the Commission's safety policies relative to freight railroads, passenger railroads, rail transit systems, and rail crossings. Rich has consistently demonstrated a keen interest in organizational development and strategic planning, and led the CPSD staff in initiatives that focused each CPSD staff member on taking a systems approach in their thinking, being objective, thinking critically, continuously improving, and being experts in their fields.

Rich is looking forward to a new role in formulating forward-looking policies for the industries the Commission regulates, particularly in the area of public safety, in his capacity as an administrative law judge. We are very fortunate to have someone with Rich's experience joining our ranks and he will be attending the National

Judicial College in August with our other new judges.
