This letter serves to advise the Commission of PG&E's 2011 electric underground conversion allocation, and supplements PG&E's December 15, 2010 letter on PG&E's 2011 Electric Rule 20A Program.

Pursuant to Section A of PG&E's Electric Rule 20, Ordering Paragraph 6 of Commission Decision No. 73078, and provisions of the 2011 PG&E General Rate Case Agreement (D.11-05-018, Ordering Paragraph 6 at p.90), we are allocating a total of \$41.6 million credits for 2011. These credits are to be used by cities and counties to plan Rule 20A projects.

The 2011 allocation for each city and county is shown in the attachment. PG&E's total conversion allocations since 1968, including the 2011 allocation, total \$1.812 billion credits.
