Chris - Here's some additional background on the story.

We have a long history of working with Mr. Moscarelli on pipeline issues and have provided him with a lot of pipeline information in the past. In fact, just a few weeks ago we invited him to observe the pigging of Line 210.

However, in this case, Mr. Moscarelli did not request the information directly from PG&E.

Rather, it appears that the genesis of the statement in the article was a request Mr. Moscarelli made to the CPUC in May of this year seeking a copy of PG&E's pipeline class density evaluation data on lines 210A and 210B. Because the pipeline class density study contains some confidential information (e.g., valve locations), it was submitted to the CPUC under confidentiality rules. As a result, the CPUC declined to release the information to Mr. Moscarelli.

We have contacted with Mr. Moscarelli and offered to provide him with the non-confidential information he is seeking. We will also follow-up with the reporter to make sure they check with us before publishing any more stories on this issue.

Concerns over PG&E transmission pipelines expressed by some Suisun City residents.

Suisun City residents ask PG&E for pipeline records

SUISUN CITY -- A group of neighbors in Suisun City has banded together in hopes of forcing PG&E to open up its records about pipelines in their neighborhood.

Residents said they are worried about a new development plan that could affect two major PG&E transmission pipelines, one 32-inches and the other 16-inches long.

Residents said they have no documentation on whether the pipeline has been inspected and if it's up to safety standards. They said they fear a repeat of the San Bruno explosion.

Anthony Moscarelli of Healthy Community Research of Suisun City said the blast radius of the pipeline would be 575-feet, almost three football fields long. If the pipeline blew up it would take out all the homes 575-feet back.

The group said the pipeline runs along an area of Suisun City where the city has plans to build a new Walmart next to those lines.

The group said they're concerned the new traffic will vibrate and possibly weaken the gas lines.

"The issue is they're going to have traffic coming down with big-rig trucks that weigh 40-tons," Moscarelli said.

They said they are also concerned over the fact that PG&E came clean last week that it didn't have inspection records for 172-miles of pipeline in the Bay Area.

The group said it fears the pipeline hasn't been inspected or maintained properly.

According to the group, PG&E told them that they cited national security as a reason why they won't release those records.
