Enclosed is an initial follow-up to our GRC meeting. Regarding the issue of base year dollars vs. nominal dollars:

- DRA's preference is that the forecasts be prepared using base year dollars.
- If the historical expense and forecast data can be provided with a breakdown by labor and non-labor that would also be preferable
- The MWC expenses are also typically loaded with some overheads which are ultimately removed / adjusted out. If the historical and forecast figures were provided without these loaded figures, that would also serve to make the estimates and preparation more stream-lined and cleaner.

We recognize that we did not discuss the 2<sup>nd</sup> and 3<sup>rd</sup> bullet points but given the opportunity we also wanted to add these ideas to the discussion.

We should be able to get back to PG&E on some of the other issues that we discussed in a few weeks.

If you would like to discuss these matters further, I will be returning to the office Friday June 24 and we can set up a follow-up conference call or meeting at that time.
