I wanted to follow up my phone conversation with Rod this morning with a note. Per recent counsel from our attorneys, I have a new appreciation for and understanding of, some pertinent CPUC rulings and corporate guidelines that will prohibit me sharing further details regarding power plant gas service outages with CAISO. Unless I have specific documented releases from each power plant customer to share details of their operations (including outages) with CAISO, I will not be able to share that information with your team. At present, I do not have such documented permissions. Therefore, I can no longer provide CAISO with the dis-aggregated information you have previously requested.

I encourage your team to continue to use the public information found at PGE.com and our Pipe Ranger website portal to assess the electric power system impacts of our various gas transmission work projects.

I do not believe this restriction impacts our real-time operator-to-operator communications between control rooms related to managing the reliability and safety of the gas and electric system.
