Subject: R.10-05-006; Correction to Calpine Testimony

To All Parties on Service List R.10-05-006:

Calpine will be making a correction to its Direct Testimony (Exhibit 601) tomorrow morning during the direct examination of Dr. Barmack. The testimony at issue is on page 15, lines 3-8. The proposed correction is noted below:

Utilizing purge credit hardware and operational practices. One of the initial stages of starting a CCGT involves clearing gas from the heat recovery steam generator (or generators) to prevent explosions. Filling a heat recovery steam generator section of the CT gas supply piping with nitrogen at shut down can obviate the need to purge the HRSG it immediately before any associated CTs are started, shortening start times.
