Hi Brian,

This is to follow up on our conversation last week to attempt to include Les

Starck into the CES-21 process sooner rather than later. I invited Les to both the Aug 29th Tour and the Aug 31st lunch at PG&E but I have not heard back from him as of yet. During our meeting with him in Rosemead, he shared with Julio and me that he is quite busy with his current position and would not begin the new assignment until after the end of this month.

I spoke to Mike Hoover yesterday regarding arranging a lunch in San Francisco during the second week of September that was suggested by Tomas to engage Les in the CES-21 process. Hoover thinks that the lunch is a good idea and will discuss it at a meeting today with Les. Moreover, during our conversation with Les in Rosemead, he raised several questions concerning the governance structure of CES-21 that need to be addressed.
