I have no corrections to the Exhibit List. However, I noted that the CAISO just responded to discovery requests from TURN and Reid. It is possible that either Reid or TURN may want to add these as an exhibit since they were received after the due date for intervenor testimony.

Also, please identify the chapters that the witnesses are sponsoring. Much of my cross time is related to rebuttal testimony. Since there is oral reply testimony and I do not know the content of the oral testimony, I find it difficult to estimate cross times.

The June 13th ALJ ruling (Ruling) states that "Any party seeking to offer oral reply testimony must show, prior to presenting such testimony, that the information it intends to present is not duplicative of its prior written testimony and that it could not be presented via briefing or cross examination." (Ruling, p. 4)

Does anyone know anything about this showing? Is this an oral showing or a written showing. If written, is this showing filed and served, or simply served? If filed, how is this filing classified for electronic filing purposes? Also, how do you show that you aren't doing something before you don't do it?
