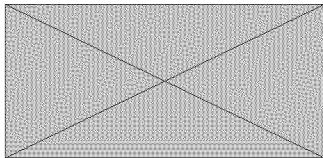

The utilities' substantial tariff and PPA filings are the main spur for our request. There are numerous issues raised by these documents and we would like to have sufficient time to draft our comments on these filings (and previously filed opening comments) and discuss with other intervenors, which would be difficult to do given the current deadline of Aug. 19.
