Matthew, Cem:

Please find below PG&E's response to your questions:

1) Please let us know any information related to Biomass QFs that is not included in the attached from Meredith Allen.

The overall status remains the same.

- PG&E has executed agreements with 9 facilities. 7 are on file with the Commission.
- PG&E expects to execute IEP extension amendments with 3 facilities within the next week or so.
- PG&E is in continuing discussions with the remaining 7 facilities

2) Please include any updated filing timeline for CHP facilities as appropriate. In your last email you noted that the first CHP RFO will not likely commence until Q1-2012, meaning that the first CHP AL would be submitted until ~ April 2012.

PG&E intends to issue its CHP RFO during the 90-day period following the CHP Settlement Effective Date. The tentative CHP AL submission date of April 2012 will be revised when the

Commission establishes the CHP Settlement Effective Date.

3) Please provide a brief update on the A. 11-07-010 PG&E GWF transactions.

PG&E filed its application on July 21, 2011, and the notice of filing appeared in the Daily Calendar on July 26, 2011. Protests are due no later than August 25, 2011. PG&E has received discovery requests from DRA.
