Draft Resolution E-4335 September 22 Commission Meeting

TO: PARTIES TO DRAFT RESOLUTION E-4335 Service List: R.11-05-005 and R.06-02-012

Enclosed is Alternate Draft Resolution E-4335 of Commissioner Michel P. Florio addressing San Diego Gas & Electric Company's advice letters (AL) 2118-E, 2118-E-A, and 2118-E-B.

The alternate draft Resolution has been modified to approve SDG&E's Advice Letter 2118-E, Advice Letter 2118-E-A, and Advice Letter 2118-E-B. Specifically, the alternate draft Resolution has been modified to grant a one-time exception to the current rules so that the REC-only PSAs, in conjunction with the previously executed and approved PPAs for the associated energy serving California load, can be treated as "bundled" renewable procurement for RPS compliance purposes.

The Alternate Draft Resolution E-4335 of Commissioner Michel P. Florio will be on the agenda at the September 22, 2011 Commission meeting. The Commission may then vote on this Alternate Draft Resolution or it may postpone a vote until later.

When the Commission votes on a Draft Resolution, it may adopt all or part of it as written, amend, modify or set it aside and prepare a different Resolution. Only when the Commission acts does the Resolution become binding on the parties.
