COMMENTS OF TRANSWEST EXPRESS LLC

Pursuant to the July 15, 2011, Administrative Law Judge's Ruling Requesting Comments on New Procurement Targets and Certain Compliance Requirements for the Renewables Portfolio Standard Program ("July 15 Ruling"), TransWest Express LLC ("TransWest") respectfully submits comments regarding administration of the California Renewables Portfolio Standard program ("RPS") pursuant to the recently signed California Senate Bill (SB) 2 (1X). ¹

COMMENTS

TransWest has reviewed the questions posed by the Administrative Law Judge in its July 15 Ruling and notes that several of the issues outlined within the July 15 Ruling most directly affect details of retail sellers' RPS procurement compliance. However, TransWest also notes that the Commission is likely to receive a variety of proposals setting forth competing views on, among other things, the ways in which retail sellers should be required to calculate and report their compliance with the procurement targets to the Commission. As a transmission developer and stakeholder in the implementation of SB 2 (1X), TransWest has certain general

comments on these issues for consideration by the Commission.²

Implementation of requirements for retail sellers to (i) satisfy previous deficits (as discussed in Questions 5 and 9) and (ii) procure minimum quantities of eligible renewable energy resources through long-term contracts (as discussed in Question 6), as well as any excess or "banking" calculations (as discussed in Questions 7 and 8) and earmarking rules (as discussed in Question 13) ultimately adopted by the Commission, must require adequate transparency. All stakeholders, not only retail sellers subject to the compliance requirements but also parties participating in the RPS program as providers of eligible renewable energy resources pursuant to Section 399.16 of SB 2 (1X), should be adequately apprised through public filings of how entities subject to RPS procurement are complying with such details of procurement.

Moreover, the Commission's review of compliance verification processes proposed by parties in response to Questions 17 and 19 should include a review of the ways in which such processes relate to the proposals—and any rules ultimately adopted by the Commission regarding verification of compliance with the portfolio content category requirements of Section 399.16—so as to ensure consistent, just and efficient administration of the RPS program.

TransWest urges the Commission to promptly adopt appropriate rules implementing SB 2 (1X) to facilitate the ability of those entities subject to the procurement

TransWest notes that while it submits general comments herein, it may submit additional comments to specific questions posed in the July 15 Ruling within its reply comments to be filed on September 12, 2011.

targets and compliance requirements to meet such requirements, consistent with the comments herein.
