Sid, sorry to ask last minute questions. But our legal department has asked me the following questions about the boat tour. I certainly hope that answers don't negatively impact our ability to participate in this section of the tour.

1. Who will be paying for the boat tour?

No money will change hands for the boat. It's a normal part of the operations to see and inspect the water flows in and out of the plant. We will just be joining the group that does this every day. There is no other way to access to this part of the plant.

2. Who will be going on the boat tour?

On the boat will be: CPUC Commissioner Sandoval and Colette Kerstan; Sidney Dietz and John Hughes, both Directors of Regulatory Relations of PG&E; and Diablo Canyon Power Plant personnel.

3. What is the purpose of the boat tour?

The purpose of the boat ride is to look at the ocean cooling system of the plant, which is best visible from the water.

Is the boat tour itself a part of the Diablo Canyon Power Plant Tour?

Yes, it is a regular part of the tour, as would be visiting the dry cask storage or the spent-fuel pool.

Or is the boat ride just a means of transportation to get to the tour site? If so, are there any commercially obtainable means of transportation to get to the tour site?

The boat is not a way to get to the boat site, but rather a way to see a part of the plant once on the site. There is no commercially alternative to this. In this sense it is like an elevator.

4. Will there be utility staff on the boat tour providing information to CPUC staff?
