All,

Please see incident from last year and its A-form. We replaced 3 feet of the 4-inch Aldyl-A pipe due to a crack in the Aldyl-A.

We CANNOT conclude the cause of yesterday's leak at this time.

- 1) Our crews did not excavate at the point of the leakage. The plan is to excavate and find the point of leakage in the next several days. (too hot to do so now)
- 2) It is not certain where yesterday's leak is in relationship to the 9/2010 repair.
- 3) There was a 2008 WRO job in this area (post-work job & sketch were prepared. Mapping is researching now). This WRO job involved the replacement of our main in at least six locations (lowered main for city project)

Please do not speculate as to the cause of yesterday's leakage until our investigation is complete.

PG&E arrived on the scene of a fire in the intersection of [Redacted] in Roseville at 1852 hours this evening. Fire in the intersection is over a 4-inch plastic gas main. There are no injuries and no structures are endangered. A gasoline station has been evacuated. Fire and Police have the intersection blocked off for 300 feet on both streets. There are no excavations in the area. Gas construction crews are enroute and will isolate the 4-inch gas main. The OEC has been activated. Sacramento TV channels 3 and 40 are on scene. The CPUC was notified at 20:48.
